#### Section 1: Preamble

This policy builds on the Governance Board Policy and outlines principles that guide our engagement with those who interact with our organisation. It ensures we meet our cultural, moral and legal responsibilities.

Goulburn Options is committed to fostering a culture that respects the Traditional Owners and Custodians of Australia. Recognising and honouring these communities is a fundamental part of our organisational values.

The Australian Government acknowledges Aboriginal and Torres Strait Islander peoples as the Traditional Owners and original custodians of the lands and waters across Australia.

As such, Goulburn Options recognises its responsibility to uphold the cultural rights of Aboriginal peoples, including:

- Respect for cultural practices
- Legal recognition under the Native Title Act 1993, Victorian Heritage Act 2006, and Traditional Owner
   Settlement Act 2010

### Section 2: Policy Statement

The Goulburn Options Board acknowledges all Victorian Aboriginal communities as the Traditional Owners and Custodians of the land and waters in Victoria. In particular we recognise the Kulin Nation, and the clans of the Taungurung people, for their ongoing connection to Country where we live, work, and meet.

The Goulburn Options Board is committed to ensuring our organisational practices:

- Respect Aboriginal and Torres Strait Islander Elders, peoples, cultures, and heritage, recognising their unique position as First Nations Peoples who have cared for this land for thousands of years.
- Support the right to continue cultural ceremonies, protocols, and practices, as outlined in the Victorian Charter
  of Human Rights and Responsibilities Act 2006 and the Children, Youth and Families Act 2005.
- Acknowledge the essential role of continued connection to Country, cultural values, and practices in supporting
  the health and wellbeing of Aboriginal and Torres Strait Islander peoples, as recognised in the UN Declaration
  on the Rights of Indigenous Peoples (2008).
- Celebrate significant Aboriginal and Torres Strait Islander events as part of standard organisational practice.
- Promote inclusive and respectful practices across Goulburn Options through relationship-building, collaboration, and partnerships with Aboriginal organisations and communities.

Goulburn Options is also committed to the safety, wellbeing, and empowerment of Aboriginal children. We actively create environments where Aboriginal children are respected, supported in their cultural identity, and encouraged to

express their views. We strive to ensure our services are culturally safe and that all staff understand the importance of cultural connection and strength in supporting Aboriginal children to thrive.
